Year-end estimates are the same for all fund classes. Per IRS regulations, mutual funds must distribute their annual realized net capital gains to shareholders.

**Important note:** Investors will not experience a loss from a distribution. The per-share amount of a distribution is deducted from a fund's net asset value (NAV). Fund prices will reflect a NAV reduction when a distribution is paid. Distributions are reinvested and the number of shares in the account will increase. This leaves the total value of the account unaffected by the distribution. Shareholder may elect to receive cash instead of reinvesting their dividends.
